4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye contact

Where Diphoterine is not available, rinse eyes with copious amounts of water for at least 20 minutes. Protect uninjured eye.

Where Diphoterine is not available, wash immediately with plenty of water and soap. Remove contaminated clothing immediately.

Inhalation

Remove person to fresh air and keep comfortable for breathing. Call a poison centre or physician if you feel unwell. If breathing is irregular or stopped, administer artificial respiration.

Ingestion

If accidentally swallowed rinse the mouth with plenty of water (only if the person is conscious) and obtain immediate medical attention. Do not induce vomiting.

Safe handling
